The notice of updates will be default sent to the Customers designated Notice contact in the Customer agreement or order form. If you want to change the notice receiving email address, please contact snowflake.hosting@dcclouds.com. While filing the request, you must provide (1) the new email address for such notifications; (2) the full name of the legal entity on whose behalf you are filing the request; (3) the legal entity authorization letter for you to file such request. By submitting this information, you represent that you have all necessary rights to provide this information to DCC.

How can current customers object to a new Sub-Processor?

If you are a Snowflake China Service customer, with a fully executed data processing agreement (“DPA”) in place with DCC for Snowflake China Service, you may notify us of an objection to Snowflake China Service’s use of a new Third-Party Sub-Processor used by sending such objection to snowflake.hosting@dcclouds.com within twenty-eight (28) days after DCC’s notice of such new Third-Party Sub-Processor, or such other period of time as set forth in your DPA. Objections shall be handled as described in your DPA and might influence your normal use of Snowflake China Service.

如果您是Snowflake中国服务客户, 并与DCC就Snowflake中国服务签订了完全执行的数据处理协议(“DPA”), 您可以通过向以下地址发送异议通知我们对Snowflake中国服务使用新的第三方子处理方的异议: 在DCC通知新的第三方子处理程序后二十八(28)天内, 或您的DPA中规定的其他期限内, 您可以通过 snowflake.hosting@dcclouds.com 提出异议。异议将按照您的 DPA 中所述进行处理, 并可能影响您对Snowflake中国服务的正常使用。
